#### **Emory Update**

- First and foremost, we want to thank you for all your support and hard work throughout the 117<sup>th</sup> Congress. We hope you have enjoyed a great start to this new year, and we look forward to working with you all throughout the new congress.
- While the public health emergency (PHE) will be coming to an end in May of this year, Emory continues to grapple with the ongoing effects of the COVID-19 pandemic as labor and supply costs continue to put significant stress on the system. These issues continue to be amplified by last year's closure of the Atlanta Medical Center.
- With these ongoing challenges facing hospitals and healthcare systems, we are closely monitoring debt ceiling negotiations and any potential cuts to programs or funding that could impact Emory University throughout the 118<sup>th</sup> Congress.
- Emory is continuing to focus on improving access to affordable higher education through our expanded Emory Advantage program and advocating for doubling the Pell Grant. We are also continuing our dedication to working with our federal partners to improve the financial aid process.

The decision to expand the program and automatically meet undergraduate students' demonstrated financial need without loans will, over time, mean more students graduate with little to no debt.
